POLICY ON WEB ARCHIVAL OF INFORMATION DISCLOSED TO STOCK EXCHANGES

WEB ARCHIVAL POLICY

A Preamble

Regulations 30(8) and 46 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, (hereinafter referred to as the “Listing Regulations” requires all listed Companies to host all the disclosures of events and other information, which have been disclosed to stock exchanges under the said regulations, on its website for a minimum period of five years. Further, the listing regulations provide that after a period of five years the said disclosures be maintained as per the web archival policy of the concerned company.

B Objective and scope

To define principles and guidelines for ensuring protection, maintenance Advance Agrolife Limited (“the Company”) disclosures, documents and records those are placed on the website.

The events or information which have been disclosed by the Company to National Stock Exchange of India Limited and / or BSE Limited (hereinafter collectively referred to as “stock exchanges”) in accordance with the listing Regulations shall be available on the Company’s website for a period of five years from the date of its hosting on its website. Upon expiry of period of five years from the date of such disclosures being hosted on the website of the Company, the disclosed event or information will be archived as per this policy.

C Removal of records from website

No disclosed information shall be deleted or destroyed or purged from the website or from archival without prior approval of any one of the Key Managerial Personnel of the Company, appointed under the Companies Act, 2013.

D Archiving & Preservation of Disclosed Events/Information

1. The disclosed events/information on the website of the Company will be reviewed on an ongoing basis. All disclosed events/information on the website of the Company would be moved to an archival folder after a period of five years from the date on which such events/information are put up on the website. The archived folder would be available for a period of five years.
2. After the expiry of five years from the date of transfer of the respective documents to Archival folder, all such disclosures/announcements will be removed from the website of the company.
3. The Company may use the services of an external vendor with appropriate experience and infrastructure in this regard.

In case the aforesaid disclosures are required by any applicable law or regulation to be hosted for a period longer than that mentioned above, such disclosures shall be hosted on the website of the Company for such longer period.

E. Policy Review and amendment thereof

This Policy shall be reviewed from time to time so that the policy remains compliant in accordance with applicable legal requirements. This Policy may be amended by the Board from time to time as and when considered necessary.

F. Dissemination of Policy

The policy shall be continuously hosted on the website of the Company i.e. www.advanceagrolife.com
